## MANAGING PSIS COMPLIANCE

Simon Fraser University (SFU) faced a challenge in managing its annual data submission to Statistics Canada's Postsecondary Student Information System (PSIS), particularly as the responsibility for this task shifted from IT Services to the Registrar's Office. With updated PSIS requirements, technical debt, and delays due to the COVID-19 pandemic, the Registrar's Office turned to Plaid for assistance. SFU has relied on Plaid's support to complete and certify the PSIS returns for 9 consecutive submissions.
